Our Pipkin Ancestry John Pipkin Sr ca 1675-before 18 JUL 1745 Our Immigrant Ancestor

John PIPKIN (Sr) was our original ancestor to come to America. He was of Welch descent, per a descendant, Lucie "CLIFT" PRICE of Austin, TX, letter written in 1955. She said that he was reputed to have come from Wales and to have been an early convert of John Wesley. Rev. J. G. JONES, who had been a close friend of John PIPKIN's descendant, Rev. Barnabas PIPKIN, for 50 years, stated in his tribute to Barnabas, that Barnabas was of English descent and that Barnabas' mother was of Welch descent. That indicates that John PIPKIN (Sr) was originally from England, may have ended up in Wales prior to coming to America. [Wales belonged to England at that time, I believe.] John PIPKIN, (Sr) was said to have been a wagon maker as well as a Methodist preacher. His birth year has been estimated, but if it is close to his true birth year, he would have been approximately 70 years old at the time of his death. [I have not seen any thing that validates him being a Methodist preacher, although this is a statement that was made by one of our earlier PIPKIN descendants that worked on the PIPKIN Ancestry starting back in the 1950's.]

[I, as compiler of a vast amount of documentation in regard to our particular ancestry, want to state that John PIPKIN's name was just plain ole John PIPKIN - period. There is a PIPKIN gentleman who has done considerable research in England, readily admits that he is an amateur genealogist, who happened to find a John Edward PIPKIN in records in England. He took it upon himself to be very positive in stating that our ancestor's name WAS John Edward PIPKIN (Sr), the immigrant, and has used that full name continually, even in a publication, that was widely sold with many falsehoods in his book. There is not a word of truth to that. If his middle name had been Edward, he would have been listed in old records in the Colonies as John Edward PIPKIN or John E. PIPKIN, and he was not at any time. He did not name any of his sons - Edward. None of his sons named any of their sons Edward, nor were there any grandchildren named Edward, and that goes on for many generations after our original John PIPKIN (Sr). If anyone has taken John Edward PIPKIN as the gospel, I would suggest that you remove that from your records, but of course it is your choice to make. All I can do is forewarn you.]

I received most of the eldest PIPKIN Ancestry information from the 'PIPKIN Family Association' newsletters, of which I got involved with many years after it was organized, thus, I was sent, unfortunately, only the pickings that verified my direct ancestry. The project had run it's course within a sort time after my contact. The editor, Col. Phillip PIPKIN, passed on and no one was willing to take his place and the Association was no longer in existence for several years. So I didn't have much desired information, but will do the best I can with what I did receive and was very grateful for the editor's help. While compiling all of this very valuable documentation, even though a lot of information contained in the correspondence was incorrect, and, I surmise that there were a tremendous amount of PIPKIN descendants that each put forth their own personal extensive effort to find all of the data at various court houses that was available at the time on all of the PIPKIN's in the very early days. What a blessing! I also believe that what I have compiled is as true as could possibly be obtained.

The Pipkin Family Association is now back in existence on the Internet under the editorship of Guy POTTS, a very good friend of mine. Now most of the old newsletters are on his website, as well as considerable, and very interesting material and pictures. My updated compilings and corrections, were placed on the website in December 2003 for the descendants of John Sr' son Lewis and all descendants located, for those descending from this ancestry to have at their disposal. I have since added more information obtained through living descendants.

Another quote - Our earliest known PIPKIN ancestor was John PIPKIN (Sr), who came to the colonies from England, some say Stanbridge Bedsford, England, but was originally from Wales and was a Welchman by birth. It has been proposed that John PIPKIN was the first immigrant, although not located on any ship roll, and that it is believed that he came over as an indentured servant and at the end of his indentured period, he was given 50 acres of land for each adult member of his family. It has been decided by current researchers that his wife's name was Martha "GOODMAN", born ca. 1680 in Nansemond County, VA. She was a daughter of Henry GOODMAN, per his 'Will'. Her mother's name has never been located to my knowledge.

There are others that say his wife's name was Martha "STEWART" or "STEWARD". I do not know which is correct without some kind of validation. She could very well have been his first wife, but she did not live long enough to be the mother of all of his children, if only but a few. If she WAS his first wife, she was deceased by 1720. Of course, this is my own opinion. John is first found in the Virginia 'Quit Rents' in 1704.

'The History of North Carolina' stated that a small party was detached by order of Captain John SMITH in 1621 from Jamestown, VA, to the post that had formerly been established on the Nansemond River. From that settlement emigrants commenced in a short time to the waters of the Albemarle Sound, by way of Blackwater and Bennett's Creek. Blackwater Creek is the headwaters of the Chowan River and either Blackwater or Bennett's Creek would have been the norm from Nansemond County to Chowan Precinct,

John PIPKIN was a renter of 100 acres of land in Nansemond County, VA. That county was the first outpost as a part of the London Company in the early 1600's, but this early outpost was not continuously occupied until 1621. The exact location of the 100 acres John PIPKIN paid tax on was not known. It had been proposed that it was in that part of Nansemond County that became a part of Chowan Precinct, NC, a few years later, then became part of Gates County, NC. Should the rent rolls have been made like a census that was house to house, the neighbors of John PIPKIN were - John PARKER, Richard BAREFIELD, John BENTON, John PIPKIN Jr, Joseph BRADDY, Christopher DUDLEY and Thomas NORRIS. The tax roll mentioned above does not include the name of Henry GOODMAN who was a long time neighbor of John PIPKIN. William Curry HARLLEE's Kinfolk's has an article on Henry GOODMAN in which it states he settled in Nansemond County as early as 1663. On 28 APR 1711, he patented 256 acres of land near Sarum on both sides of Peter's Swamp in that part of Nansemond County which later became part of Gates County, NC, and as of this time period is still contained in Gates County, NC.

The next mention of John PIPKIN Sr is found in the 'Colonial Record of North Carolina, Vol V, 1709-1723'. On 1 NOV 1711, John PIPKIN appeared before Nathaniel CHEVIN, Francis Del LaMARE and Johnathan JACOBS, Justices of the Court, and asked that Adam KNIGHT's request for release from his indenture, approved at the October Court, be withdrawn. John PIPKIN announced he had purchased Adam KNIGHT's remaining period of indenture from Nicholas CRISP and Adam was to serve until the age of 30, which he was not.

The following is in regard to the Land Patent granted to John PIPKIN bearing the date of 4 APR 1720 and this following transaction took place in 1780 - Gates County, NC, Land Deeds 1776-1795 - (Marilyn Poe LAIRD, Vivian Poe JACKSON and Judith Krause REID)

8 FEB 1780 - William GOODMAN, Senr. - To my son, William GOODMAN, Jr - Good Will and Respect I owe to my Dutiful Son, William GOODMAN - 170 acres of land I purchased from my son, John GOODMAN, sit. Mouth of a branch called Long Branch, joining Henry GOODMAN and Isaac PIPKIN, part of a patent granted to John PIPKIN, decd, bearing date 4 APR 1720. Signed William GOODMAN, Wits: John BETHY and Henry GOODMAN.

John PIPKIN Sr and John PIPKIN Jr were both granted 640 acres of land in Chowan Precinct on 1 MAR 1719/20. John Sr's grant is found in 'File #878, Book 8, page 212, of Chowan County File in Dept. of State at Raleigh, NC'. It reads as follows:

"To all to whom &c know ye &c Do give and grant to John PIPKIN a tract of land containing 640 acres lying in Chowan precinct beginning at a water oak nigh the head of Long Branch which said Branch comes out of PETER's Swamp, than N. 55 W. 175 po. To the centre of two pines and a Black Oak in Sam'l MERRIOT's line then along his line N. 33 E. 40 po., then N. 37 E. 118 po. To a dead pine Sam'l MERRIOT's corner, then the same course N. 37 E. 179 po. To a Wt Oak then N. 20 E. 80 po. To a poplar nigh a swamp than thro the said swamp S. 75 E. To a pine Henry GOODMAN's corner, then along the said GOODMAN's line S. 23 W. 198 po. To a pine, then S. 56 E. 118 po. To a pine by PETER's Swamp, then down the various courses of the said Swamp to Long Branch then the various courses of Long Branch to the first station. To hold &c 1 MAR 1719/20.

Witness &c Chas. EDEN, Thos. POLLOCK, Fred JONES, Rich'd HECKLEFIELD."

A great effort was put forth in 1976 to locate this land, loaded with maps, geological surveys and everything else they could think of, but it was in vain. Although it was establish that the little township of Sarem became Buckland and it was learned that the Meherrin Indians were present during those olden days and there had been a school there specifically to educate the Indian children. An Episcopal Chapel was also established there.

Guy POTTS, the editor of The PIPKIN Family Association Newsletter, as well as owner of The PIPKIN Family Association website, has visited the old Isaac PIPKIN Jr home and the surrounding area. There are pictures on the website of the old home taken during restoration. A previous owner, Sam NIXON, restored the home back to it's original structure of ca 1760. The home was built for Isaac PIPKIN, Jr, (grandson of John PIPKIN Sr), when he married and it is located on a section of what had been John PIPKIN Sr's land. It is now referred to as the PIPKIN-GOODMAN-EDWARDS land. It is a very large home for that time period, so it is proof, to me anyway, that John PIPKIN, Sr, nor his earlier descendants could possibly have been considered paupers in their day and time.

John PIPKIN Sr was mentioned a number of times in early NC records following the land grant. He was a juryman in Chowan Precinct in 1723. He witnessed land transactions in 1725. The following extract of deeds are all that were found in which John PIPKIN Sr was a principal -

'Chowan County Deed Book W, page 206-7', John PIPKIN Sr to John PIPKIN Jr, 17 JAN 1732. For an unspecified amount of shillings, a part of the patent granted to Charles SCOTT on 17 APR 1694 beginning at the mouth of a branch that runs out of (Nickel) Swamp and running up the swamp to beginning of the patent line to a marked hickory, then to a number of identified branches and trees that would not now be identifiable. Signed 17 JAN 1732 by Jno. PIPKIN and witnessed by Simon DANIEL, Wm. W. BENTLEY and Henry GOODMAN. [This is an indication to me that his name was 'possibly' Johnathan, called John.]

'Chowan County Deed Book W, page 308', Richard HINES to John PIPKIN, 19 SEP 1735. For and in consideration...of 37 barrels of every way good merchantable tar, Richard HINES sold John PIPKIN 160 acres of land that had formerly belonged to Charles SCOTT and by him sold to Richard HINES in APR 1695. The land began at a pine on the SW side of a swamp that runs into Sarem Swamp commonly called MILLSE's Swamp..Signed by Richard (R.) HINES and witnessed by George T. WILDE, John (x) HINESES and William BUTLER.

'Chowan County Deed Book W, page 295', Joseph BRADDY to John PIPKIN, 2 AUG 1736. For 100 pounds current money of NC, 180 acres of land beginning on PETER's Swamp, running up the swamp to the mouth of Long Branch and up said branch to Samuel MERRITT's line and along MERRITT's line to William PARKER's line. Land granted to Joseph BRADDY on patent of 17 MAR 1717. Signed Joseph BRADY and witnessed by Henry BONNER Jr and George PULLY.

John PIPKIN Sr gave this 180 acres of land that he obtained from Joseph BRADDY to his son, John PIPKIN Jr, as his inheritance. This is borne out by a deed of 16 OCT 1740 from John PIPKIN Jr to Moses HARE (Chowan County Deed Box C, pages 79-80) in which John Jr states that he 'is lawful owner...and possessed of the same in my own proper right as a good perfect and absolute estate of Inheritance in fee simple...'

Most importantly, John PIPKIN Sr left a 'Will' dated 21 MAY 1745 in Chowan County, NC. This 'Will' is recorded on page 56, Vol. XXIV of 'North Carolina Wills, 1663-1789' in which he listed his wife and children. The 'Will' reads as follows:

"In the name of God Amen, May the Twenty first Day, 1745, I, John PIPKIN of Chowan County in North Carolina being sick and weak but of sound mind and perfect memory, praise be to Almighty God for it, do make and ordain this my last will and testament in manner and form following, that is to say first and principally commended my soul into the hands of Almighty God hoping through the meritorious death and (illegible word) of my Savior Jesus Christ to have full and free pardon and forgiveness of all my sins and to inherit everlasting life and my body committed to the earth to be decently buried at the discretion of my executors hereafter named

and as touching all such temporal estate as it has pleased Almighty God to bestow upon me, I give and despose there of as...First my will is that all my just debts and funeral charges be honestly paid and discharged... IMPRIMIS - I give and bequeth to my son Phillip PIPKIN my plantation where I now live to him and his heirs forever and in case he dies before he comes to age to go to my son Joseph PIPKIN and as far as my land marked by a line of marked trees joining to my plantation I give and bequeath to my two sons Lewis and Isaac PIPKIN being part of the survey of land I now live upon southward, I give to my son Lewis PIPKIN and the west part to my son Isaac PIPKIN. I give to them and their heirs forever. ITEM: I give and bequesth to my son Daniel PIPKIN a piece of land upon Milly Swamp being part of the tract that his brother John PIPKIN (Jr) should dye then the said land to fall to the brother in corse.

ITEM: I give to my son Joseph PIPKIN a negro boy called Jack and my riding horse and bridle and saddle.

ITEM: I give to my son Daniel PIPKIN two leather chairs, two pewter dishes and three pewter plates and two cows and a calf and a young steer about 2 or 3 years old and 2 sheep.

ITEM: I give to my son Isaac PIPKIN a negro boy called Rollin.

ITEM: I give to my son Steward PIPKIN a feather bed and furniture belonging to it and biggest oval table and two pewter dishes and 3 plates and 1 iron pot, 2 cows and calves and young steer of 2 or 3 years old and 2 sheep.

ITEM: I give to my son Jesse PIPKIN a negro girl called Dorety. ITEM: I give to my daughter Mary PIPKIN a negro girl called Dina. ITEM: I give and bequeath to my younger daughter Martha PIPKIN a feather bed and furniture and least oval table, 2 pewter dishes and 3 plates one iron pot 2 cows and calves and a young steer and 2 sheep and also I give to my son Phillip PIPKIN a bed and furniture and young heafer and a steer about 3 years old and if in case any of my children herein mentioned should die before they come to age then their part be given whatever it be negro, or household stuff or cattle to be equally divided amongst the rest herein meantioned.

ITEM: I give to my loving wife Martha PIPKIN a negro woman named Hannah and her increase from the date hereof and my negro man Ned and all the remaining part of my estate goods, chattels during her natural life or widowhood and then to be equally divided among my children herein mentioned and LASTLY I appoint and nominate my loving wife Martha PIPKIN and my son Joseph PIPKIN to be my Executors of this my last will and testament utterly revoking all other will or wills that hath been made by me heretofore.

John (x) PIPKIN, his mark

It witness whereof I have hereunto set my hand and fixed my seal. Signed sealed and delivered in the presence of Henry GOODMAN Sr, Henry GOODMAN Jr, Timothy GOODMAN.

Proved in his Majesty's Court of Chowan County, NC, 18 JUL 1745 with Martha PIPKIN and Joseph PIPKIN issued letters of Administrations. Minutes of The County Court of Chowan County, NC, Dept of Archives and History, Raleigh, NC. DEC Term, 1745, 'The Last Will and Testament' of John PIPKIN deceased was exhibited into Court by Martha PIPKIN and was duly proved in open Court by the oath of Henry GOODMAN Sr and at the same time the said Martha PIPKIN and Joseph PIPKIN, executors, thereto by taking oath by law appointed to be taken by Executors.

[One of the first thoughts that went through my mind as I was typing John PIPKIN Sr's 'Will' was the fact that Martha was a GOODMAN for sure, just because of the way legal matters were handled back in the early days. The following bears that out. I also found it amazing that the 'Will' was even available! This was way prior to the Revolutionary War! Although I can not shake my 'feelings' that at times I felt like I was typing data on not only John Sr and John Jr, but also, at times, another John PIPKIN. This will show to be more evident when typing the data on Joseph PIPKIN, considered the third son of John PIPKIN Sr.

The following list, may very well be the children of John PIPKIN Jr, (there is a large age difference mentioned.) You will have to make your own decision because I am not an authority on the children of John PIPKIN Sr except with the exception of Lewis PIPKIN, who died quite early in life.

Unfortunately, there appears to be no extant records that give the exact ages or year of birth of the children of John PIPKIN Sr. The 'Will' is specific that Phillip is not of age and that Martha was the youngest daughter, and that others were not of age, but nothing that you could use to determine dates. Assuming that John of 1704 is the same John of the Land Grant of 1719/20 and that he (Sr) is the one who left the 'Will' in 1745, there are certain things that can be deduced from available data. First, the surviving widow, Martha "GOODMAN", may have been a second wife. This assumption is made due to the language of the 'Will', "..to be equally divided amongst my children..." Not OUR children, but MY children; and also due to the apparent differences in ages of the children. John Jr. received a land grant in 1719/20 and must have been at least 16 years of age or born ca 1703, while Phillip being under age in 1745, must have been born after 1730. While it is not impossible for Martha to be mother to both Phillip and John Jr, it is not probable. A long deceased descendant left in his notes on the early family that he believed the first wife of John PIPKIN of the 'Will' was a STEWARD. There were a number of STEWARD families in that part of VA and NC. The widow, Martha, has been proposed to be a GOODMAN due to the apparent closeness of the 2 families, but this could have been due to the intermarriages of the children rather than John Sr. But this is only a possibility. The assumption is also made that those who did not receive land were already of age and had received their share of the estate as they reached the age of maturity. This group includes Steward, Mary and Jesse. John Jr had already received his inheritance.

Because of the fact that no one knows for sure, a 'suggested sequence' for the children of John PIPKIN Sr by the 'PIPKIN Family Association', January 1978, Vol. 11, pgs XI-5 and XI-6, are considered to be:

- John PIPKIN Jr was undoubtedly the oldest male of the family. Considering he received a grant of land in 1719/20 and that he was already married by FEB 1730, you could place his year of birth ca 1703, which would have made him born in Nansemond Co, VA.
- 2. Joseph PIPKIN was probably the second oldest male, due to him being appointed executor of the estate. The 'Will' did not provide him any land but on a contigency basis in the event his younger brother Phillip died before coming of age.

[The following data on Joseph PIPKIN was in another issue of 'PIPKIN Family Association Newsletter'.]

Joseph PIPKIN was very probably born in Chowan County, NC, on the grant of land his father John received in 1719/20. Joseph's exact age can not be determined, to my knowledge. Considering that Joseph had a son born about 1745, and the number of younger siblings he had, it is assumed that he was born at least by 1720. Also Joseph was probably appointed the executor of his father's 'Will' due to him being the eldest son in the area.

Joseph PIPKIN m. Susannah "YEATES", d/o William YEATES of Bertie Co, NC. William YEATES left a 'Will' in Bertie County on 3 DEC 1751 in which he names one of his daughters as the wife of Joseph PIPKIN. The 1769 Dobbs Co, NC, 'Tax List' has Joseph and sons Elisha and Willis as taxables, which would show they were at least 16-18 years of age, thus b. about 1751 or earlier. It is not known when Joseph left Chowan Co, NC. The index of 'Deeds of Johnston Co, NC,' shows he had a land transaction in 1747, which would put him in that county two years after his father's death. Joseph was a Justice of the Peace in Bladen County in 1759 and as Justice of the Peace in Dobbs County in 1761. There is a notation made in 1761 stating that he refused to qualify for the office. He was issued a commission as Ensign in the Dobbs Co, NC, Militia on 23 APR 1761, in the company of his brother, Lewis PIPKIN, who commanded as Captain at the time of Lewis' death.

Joseph PIPKIN was a very successful plantation operator and an influential person in the community. The land records of Johnston, Dobbs and Wayne Counties, records many transactions where he is a principle. He 'Willed' over 2,180 acres of land to his sons and had given one daughter at least 360 acres of land at the time of his death. He was named Justice of the Peace for Dobbs County by Act of the General Assembly in 1776 and again in 1778, as recorded in 'NC State Records, Vol. 23, page 993, and Vol. 9, page 1028'. In 1779, that part of Dobbs in which he was living was changed to Wayne County. The men named in the act as Court House Commissioners failed to serve and in 1782 Joseph PIPKIN, Stephen COBB, and

Needham WHITFIELD were named commissioners and were serving in 1784 when Dr. Andrew BASS gave 3 acres for the erection of a public building.

The 'NC Revolutionary War Accounts, Vol. 1, page 33, Folio 2', show that Joseph PIPKIN was paid 9 pounds and 4 pence on 23 OCT 1783. Whether this was for service, or for goods, is not known. His descendants are eligible for the DAR and SAR on his service as Justice of the Peace. Joseph did not apply for a pension for any war service, although he was in the Revolutionary War.

Joseph PIPKIN left a 'Will' in Wayne Co, NC, dated 19 JAN 1789, which says -"To wife, Susannah PIPKIN, 4 negroes towit Nero, Dinah, Priscilla, and Galloway during her natural life, then after her death Nero and Galloway to be given to my son Elisha PIPKIN. Also to wife, one horse, feather bed and furniture. To son Willis PIPKIN, 2 negroes after my wife's decease the name of Dinah and Priscilla. Also 3 others by the names of Cesar and Kimrock and young Rose. Also 400 acres of land on North side of Falling Creek and both sides of KELLEY's Branch; and 300 acres adjoining the above acreage. Also --- acres on North side of upper branch of Falling Creek and 80 by the name of RAIN's Place. To son Elisha PIPKIN, the Manor Plantation where Joseph lived containing 200 acres, 20 acres adjoining the Plantation, 200 acres adjoining the plantation and an additional 250 acres also adjoining, plus 110 acres adjoining William RHODES and 300 acres also adjoining Elisha's line, also one negro man named Old Ben and his wife Venus, a negro man Jack and his wife Rose, Negro Dinah and Negro boy Simon. To daughter Mildred JERNIGAN, negroes Tom, Phillip and Betty. To daughter Susanna BECK, negroes Philip, Sawney, Jude and Olive. To daughter Mary CRADDICK, negro boy named Burrel. To daughter Nanny RHODES, negroes Vinah, Doll and Penny. To son Elisha, tract of land containing 170 acres adjacent to his own land 150 acres known as KELLEY's place. To son-in-law Lewis McCULLEN, 5 pounds specie. To daughter Mary CRADDICK, negro named Ester. Residue of estate to be put into lots and the children to draw for them. Son Elisha PIPKIN, son-in-law David JERNIGAN and son-in-law John BECK Signed by Joseph PIPKIN" Executors.

The date of Joseph's death is not known. He had died prior to the death of his wife, Susannah, which occurred on or before 1 FEB 1792. On that date her son-in-law John BECK took Inventory of her personal estate. John BECK was granted Letters of Administration of Susannah's estate on 13 JAN 1793 and held a sale on 1 FEB 1793. These last 3 actions are recorded on pages 107 to 109 of Wayne County Settlements of Estates, NC State Department of Archives and History.

- 3. Steward PIPKIN was probably the third oldest son. This is based on the fact that he was not given land, not even on a contingency basis. That he was given household goods would indicate he was not married and was living at home. He was married prior to DEC 1755 and would have been born prior to 1728, some say ca 1715, and b. in Chowan Co, NC.
- 4. Mary PIPKIN is a puzzle. From the lack of receiving any household goods it would appear she was already married, on the other hand if she was married her father would have used her married name. She was considered of age. Henry GOODMAN Jr left a 'Will' dated 31 MAR 1817 'North Carolina Historical and Genealogical Register, Vol. 2, page 49' in which he names his sons William, Dempsey and daughter Martha, their mother Lucretia GOODMAN and my children by Mary PIPKIN, first wife, viz: William PIPKIN and Penelope PARKER. Henry also named a great granddaughter so this could be that this particular Mary PIPKIN, was the d/o John PIPKIN Sr. [All of the above regarding Mary PIPKIN is a direct quote from a 'PIPKIN Family Newsletter' and the editor was even puzzled. If I had the 'true' document in front of me, I might be able to evaluate it better.]
- 5. Jesse PIPKIN was probably an older son and did not receive any land or household goods. He was probably born prior to 1724, although some researchers in his line believe he was born as late as 1737-1740. Another says ca 1727 in Chowan Co, NC, d. 1814 in Lenoir Co, NC.
- 6. Lewis PIPKIN Our next direct ancestor will be listed separately.
- 7. Daniel PIPKIN was not married at the time of the 'Will' and may have been of age. Some say that he was b. ca 1725 in Chowan Co, NC. He moved to Pitt County

where he was in the 'Tax List' in 1762.

- 8. Isaac PIPKIN was not married at the time of the 'Will' but was probably of age. Some say that he was b. ca 1730 in Chowan Co, NC. He was given a part of the homestead and remained in the Chowan District, NC, even after it became Gates County, NC.
- 9. Martha PIPKIN was the youngest daughter, unmarried and living at home. Some state that she was b. ca 1732 in Chowan County, NC. No other information is available at this time concerning Martha, to my knowledge.
- 10. Phillip PIPKIN, b. ca 1735 in Pitt Co, NC, was the youngest son, and was given the family homestead where he probably lived until his mother died. He m. Martha "PARIS", b. ca 1748 in Pitt Co, NC. He was still in Pitt Co, NC, in 1775. It is believed that he d. in 1790 in Pitt Co, NC.

The data on John PIPKIN Sr contained in the above pages were found in the "PIPKIN Family Association Newsletter" dated JAN 1978, Vol. II, No. 1. All of the Newsletters are available to view on microfilm at the Mormon Latter Day Saints in Salt Lake City, Utah, and many are available to view on the new Pipkin Family Association website, those that are available on the website.

I see no need to try to pursue the balance of the siblings, other than our 'proven ancestor' because I do not have all of that information available anyway. When there are misspelled words within a document, I do not correct the spelling.

Lewis Pipkin ca 1725-1763

Lewis PIPKIN was a son of Rev. John PIPKIN Sr and Martha "GOODMAN". His birth date is estimated by others as ca 1725 and it is 'considered' that he was born in Chowan County, NC. Lewis PIPKIN was identified through his father's 'Will', the 'Will' of which implies that Lewis was probably of age, but not married and living at home at the time of the 'Will'.

Lewis PIPKIN is believed to have moved to the Falling Creek area of Johnston Co, NC, sometime after his father's death. It is not known what he did with the land he inherited from his father. As of 1981 no record had been found by any member of the PIPKIN Family Association that says when he sold it and to whom he sold it. Beings that his land was adjacent to his brother Isaac's land, it is possible that he sold his land to Isaac. Isaac PIPKIN stayed on the home place and did increase his holdings.

The first evidence of a Lewis PIPKIN in Johnston, Co, NC, was when he purchased land from James BARBEE about 1751 (Book 2, page 123). In Book 5, page 529 (1758-61) Lewis PIPKIN sold land to Richard COGDELL. The records of Johnston, Dobbs, and Lenior Counties were burned in 1878 and only indices of those early records are available. Thus no land or marriage record for Lewis PIPKIN is available, unfortunately.

The Officers for Dobbs County (NC) Militia on the roster of 11 MAR 1761 shows Lewis PIPKIN as Captain. During the period this roster was used, Lewis died, and this is believed to have taken place in 1763. Following his name on the roster is the notation - 'died during the year'. There is no record, or evidence, that Lewis was married or that he had any children, but it was believed by his descendants that he was the father of our Stephen PIPKIN.

Elsewhere I found mention that Lewis PIPKIN probably married a Mary "MARTIN", born ca. 1750 in Dublin County, NC. [A 'novice' in the art of genealogy would buy that notation 'hook, line and sinker' with no hesitation or thought of any kind!] This notation was written down during the various correspondence of the elder descendants, as if a probable true fact, during the long period of letter writing beginning in the 1950's. It was NEVER retracted, as many obvious errors were. Beings that all of this correspondence is posted on the new website for the new 'Pipkin Family Association Newsletter' - some one may notice this and then the rumor will grow as being a true fact that OUR Lewis PIPKIN, indeed did married a Mary "MARTIN". Just remember this - There is not a word of truth in that notation. HOW can this Mary "MARTIN" possibly even be the mother of Stephen PIPKIN when she wasn't even born until around 1750, give or take 3 or 4 years. Lewis PIPKIN's son, Stephen PIPKIN, was born in 1757. I do

hope that if any one has this already posted in their records, that they will remove it immediately, but if not, they have at least been forewarned.]

Three of the PIPKIN brothers, John Jr, Joseph and Lewis all settled in the Falling Creek area. Joseph is the only one who left a 'Will', that I am aware of. Thus the parentage of the other PIPKIN men who were in the Falling Creek area is only guessed at. John PIPKIN Jr. was known to have been married by 1730 and most of the families living in that area are considered to be his descendants.

An intriguing 'Will' found in Wayne County, NC, is that of Richard MARTIN, who left a 'Will' dated 8 MAR 1786. He named his wife, Franky, and his children - Aaron, Richard, Betty, Lydia, Bitha, Sally and Mary PIPKIN. He left one shilling to the heirs of his deceased daughter, Mary PIPKIN. The husband of Mary is not mentioned. The executor of the 'Will' was Dr. Andrew BASS whose wife, Alice, was a sister to Nancy and William RHODES, William being the pastor who performed the marriage ceremonies for Willis PIPKIN and Nancy PIPKIN, children of Joseph PIPKIN.

One of the PIPKIN men in the Falling Creek area whose parents were not known was Stephen PIPKIN. Stephen PIPKIN was born 2 AUG 1757 in Dobbs County, NC. He later bought, or was given, land by Joseph PIPKIN in 1778 and 1779.

[It has been very well 'accepted' by many descendants of Stephen PIPKIN that he really WAS a son of Lewis PIPKIN. He did not fit into the families of any of John PIPKIN Sr's other children. The fact that Stephen received land from Joseph PIPKIN does leave one to suspect that Stephen WAS a son of Lewis PIPKIN. Lewis PIPKIN lived only a short life and he didn't live long enough to establish any identify for himself separate from his brothers, mostly because he died in 1763. Many of the descendants of Stephen have looked at him as the only son of Lewis PIPKIN, due to Stephen naming his eldest son, Lewis. Stephen was only 6 or 7 years old at the time of his father's untimely death. To my knowledge, it is unknown who was kind enough to take care of little Stephen in his young years prior to adulthood, because it has not been mentioned.

Stephen Pipkin 2 AUG 1757 - after MAY 1836 and Early 1840

Stephen PIPKIN was born 2 AUG 1757 in Dobbs County, NC, being Wayne County, NC, and stated to be of Welsh and English descent. No one moved through time. Stephen is considered the son of Lewis PIPKIN and his true mother's name is UNKNOWN. His profession was known as being a planter, planter of what, I do not know, but 'possibly' corn, cotton, or tobacco.

The following is the 'background' of Stephen PIPKIN's account of participation in the Revolutionary War as stated in his pension application of 1837. [I do not know where this information was obtained.]

In 1776 - In North Carolina the patriot cause was victorious in the opening months of this memorable year. The Royalists or English sympathizers (Tories) were strong in the Carolinas and Georgia, and Sir Henry CLINTON was sent from Boston to the Cape Fear River before the close of January to cooperate with these sympathizers and to restore royal authority in the South. The patriots, about 1,000 in number under Col. James MOORE took position at MOORE's Creek Bridge (called Widow MOORE's Creek by Stephen) where the loyalists must pass on their way to the coast. Here, on February 27th a fierce battle occurred in which the Americans were victorious; they captured a great quantity of military supplies and 900 Loyalist prisoners, with their commander. Soon 10,000 men were armed and ready to march to the coast to expel the invader, but CLINTON decided not to stop at Cape Fear. As early as May 31, 1775 the people of Mecklenburg County adopted resolutions of independence and after the fight at Moore's Creek the sentiment had spread throughout all North Carolina.

Stephen PIPKIN took part in the Battle of MOORE's Creek, 27 FEB 1776, serving under General Francis MARION, and filed an Application for a Revolutionary War Pension dated 5 SEP 1836. The War Department denied his Application because his name could not be found on any roll.

As to the first 3 companies of Minutemen, Johnson and Holloman's 'The Story of Kinston and Lenoir County.' - "Dobbs County raised 3 companies of Minutemen - [in part] - The younger Company 'B' presented itself to the Commission of Safety in SEP 1775 and was inducted.

Some of his descendants tried to obtain a Land Grant because of his service in the Revolutionary War. One of his descendants that wrote inquiring about his Pension was Mrs. Stephen W. PIPKIN of Beaumont, TX, on 22 JUL 1907. Another member of the family that wrote was Mrs. Lewis Beauregard PIPKIN of Beaumont, TX.

In the JUN 1964, Vol I, #8 of the Pipkin Family Association Newsletter contains all of the Revolutionary War information on Stephen PIPKIN obtained by Lucie "CLIFT" PRICE, an excellent 'sleuth'. The complete obtained information is as follows -

Application for Revolutionary War Pension - Photostat obtained from National Archives, Washington, D. C, Record Group #15A-R8269, 9 pages.

Sir - The declaration of Stephen Pipkin has been exnd. He alleges to have volunteered in 1775 or 1776 in Capt. George Miller's company and Colonel Richard Caswell's Reg't as a militia man of North Carolina for six months, and that he afterwards was drafted at two different times and hired substitutes to serve in his place. The militia of North Carolina was not called out at the period alleged to serve 20 ---- or six months. There are rolls of the North Carolina militia in this office and it appears therefrom that Captain Miller's company was in service less than two months. The Act of 7 June 1832 provided for none who did not in person perform six months actual service. The claim has consequently been rejected and the papers filed in this office.

On this fifth day of September in the year of our Lord, one thousand eight hundred and thirty-six, personally appeared in open court before Jeptha V. Perryman, Judge of the County Court of Conecuh County, Stephen Pipkin a resident of Conecuh County and State of Alabama, aged seventy-nine, one month and two days, having been born in Daubs [Dobbs] County in the State of North Carolina, on the second day of August in the year of our Lord seventeen hundred and fifty-seven, who being first duly sworn according to law, doth on his oath, make the following declaration, in order to obtain the benefit of the Act of Congress passed June 7th 1832.

That he entered the service of the United States, under the following named officers, and served as herein stated. That he volunteered his services in the State of North Carolina in the service of Daubs [Dobbs] County, and that he entered the service in the month of September as he thinks some time about the last of that quarter 1775 or 6 and that the company of which this applicant was a member, volunteered for six months and was commanded by George Miller as Captain and Benjamin Exum Lieutenant, which company was attached to the Regiment commanded by Col. Richard Caswell. This applicant says that the company which he joined was required to march immediately from Daubs [Dobbs] County North Carolina to the widow More's [Moore's] Creek Hanover County, the British being at that time stationed at Wilmington and the tories were expected to attempt to join them, to present this, and to cut off the Tories from the British, the company was called out so early and stationed at the widow More's [Moore's] Creek as above stated; that on the morning after arriving at the creek, the Regiment consisting of about thirteen hundred men, was attacked by the Tories, supposed to be of much larger forces who were attempting to force their way to Wilmington to join the British and they, the Tories, were routed and dispersed and forced to retreat.

The Regiment then returned to Kingston Headquarters, on Neuse River in Daubs [Dobbs] County, where it remained a short time, and then marched to Newburn, from Newburn to Wilmington, to attack the British thinking they

were still there, but they had before that time left, and, the Regiment remained at Wilmington until the expiration of the time of service, which was six months. Shortly after this time, this applicant was drafted for five months and hired Thomas Grantham as a substitute who served out his term without being in any battle or engagement, being principally employed against the Tories. At the time Charleston was in the possession of the British this applicant was drafted a second time for nine months; the object of which draft was to raise troops to march to Charleston, and hired William Peters as a substitute, who served until the close of the war or until the expiration of the nine months. The foregoing statement contains all that this applicant can furnish in his He received a discharge at the expiration of the six months when he volunteered, by Col. Richard Caswell, but does not recollect whether he received a written discharge, if he did he has lost it. This applicant does not know if any surviving witness or person who served with him in the army, if there is any one it is one Elisha Harrell who resides if alive, in South Carolina Darlington District.

The said Stephen Pipkin, hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the agency of any State. Sworn to and subscribed this $5^{\rm th}$ day of September 1836. /s/ Stephen Pipkin

We, Blanton P. Box, a clergyman residing in the County of Conecuh and State of Alabama; Whiting Oliver, residing in the same county and state, hereby certify that we are well acquainted with Stephen Pipkin that we believe him to be seventy-nine years of age; that he is reputed or believed to have performed services in the Revolutionary War and in that opinion we concur.

[If anyone was really paying close attention to the statement of when Stephen PIPKIN was born, mentioned in the papers above, I noticed a discrepancy. I do not know if it was a typing error, or not. But the document states that it was 5 SEP 1836, and it states that Stephen was 79 years, one month and 2 days old, then goes on to say that Stephen was born on 2 AUG 1757. Using those exact figures, Stephen was born 3 AUG 1757, not 2 AUG 1757. I would have to see the 'original document' in order to say for sure what his full birth date really was, although we may never know.]

The following was written by Jean B. GRAY, a descendant, in 1994, speculating about Stephen's Pension Application:

"The 'Panic of 1837' may have caused a drop in income, hence the application for a pension, tho he applied in 1836. It is not known if he actually needed the pension or not. It is not known why he hired substitutes, except that it was the custom to do so in those days, and allowed, so evidently Stephen had the money to do it. His oldest son Lewis was born in 1777 and he may have had great responsibilities at home. If the Pipkin's were from England or Wales, as is thought, there may have been a feeling for the 'old country'. Also, if Stephen was the early convert of John Wesley, there may have been religious feelings about war. All of this is purely conjecture and not proven at all. It is not known who Wm. Thompson was, who was being considered at the same time for a pension but Stephen Pipkin married Amelia Thompson, so this could have

been her brother. The Blanton P. or I. Box who was a witness for Stephen was an early Methodist preacher of Alabama in Conecuh County. We are of the belief that Stephen served his six months as he alleges, and the refusal by the War Dept. was based on rather vague reasoning."

Sampson County - Duplin County, NC, Deeds 1750-1774, Deed Book 7, page 177 - Marmaduke TEW and Rebeckah TEW to William THOMPSON, dated 21 MAY 1783. Witnesses - Roger SNELL and Stephen PIPKIN

Sampson County - Duplin County, NC, Deeds 1750-1774, Deed Book 7, page 245 - John Sampson YOUNG to Curtis IVEY dated 25 SEP 1783 - Witnesses Henry Jones, Stephen PIPKIN and Thomas IVEY.

Sampson County - Duplin County, NC, Deeds 1750-1774, Deed Book 8, page 129 - Theophilus WILLIAMS to John Sampson YOUNG, dated 25 SEP 1783 Witnesses, Henry JONES and Stephen PIPKIN

Stephen PIPKIN acquired two pieces of land from Joseph PIPKIN, son of John PIPKIN of Chowan. The first - Joseph PIPKIN to Stephen PIPKIN, is recorded on page 205, Dobbs County Deed Book II, JAN 1777 to APR 1779. The second - Stephen PIPKIN from Joseph PIPKIN is on page 477. This is index data only, for the deeds were burned. It has been proposed that the land may have been his inheritance left in trust with his Uncle Joseph PIPKIN. (Dobbs County, NC, was formed from Johnston County, NC, in 1758. Wayne County, NC, was formed from Dobbs County, NC, in 1779.)

The Duplin County Marriage Bond contained in the North Carolina Archives - "Know all men by these presents that we, Stephen PIPKIN and William THOMSON both of the County aforesaid are held and firmly bound unto his Excellency Richard CASWELL, Esq. Governor of the state in the full sum of Five Hundred Pounds current money of that said state to be paid to the said Governor or his successors in office to which payment will and truly to be made we find ourselves each of us our Executors and Administrators jointly and severally firmly by those presents Sealed with our seals and dated this $21^{\rm st}$ Day of April 1779. The condition of the above obligation is such that whereas the said Stephen PIPKIN above bound hath this day of the date hereof made Application to the Clerks office in our said County for license to Celebrate and Solemnize the Rites of Marriage between him to said Stephen PIPKIN and Amelia THOMSON both of the said County, single woman and hath obtained ... same now if it shall not happen at any time hereafter that there will be no Lawfull cause to obstruct the said marriage then the above obligation shall be void of no force, otherwise to stand and remain in full force and virture. Signed Sealed and Delivered in the presense of Wm. LUKSON, CC

15 MAR 1802 - Darlington District, SC - Deed Book A, p. 363 - Stephen PIPKIN deeds land to his 'loving step-son', Stephen THOMPSON 100 acres on Sparrow Swamp, below GOODSON's Branch. Witnesses: Bennett BIZZLE, Bartholomew FIELD.

[I do not believe that Stephen THOMPSON was his step-son. Because of this error in mentioning him as a step-son, many PIPKIN researchers decided that Stephen's wife, Amelia, my ancestor, had a child out of wedlock and I personally feel that is/was ridiculous. First of all, they had been married since 1779 in Duplin County, NC, before they even moved to Darlington District, SC. I do realize that the first 'PIPKIN Family Association Newsletter' was printed in DEC of 1963, and it took them a number of years to finally learn a tremendous mass of information, but I did want to make sure that this issue was 'nipped in the bud' as soon as possible, although this comment about Amelia was written in 1982. It was also written that Amelia's father was positively David THOMSON and anyone who even considered that the surname was THOMPSON did not know what they were talking about. I do not agree with them, but everyone has the right to their own opinion. I realize that these were early evaluations of certain bits and parts of information and comments made here and there in those earlier times, trying to make decisions of various things, many of them wrong. These comments were later retracted when more of the 'true' facts were evident, so it is not meant on my part to be critical of their earlier 'thoughts'. The court clerks etc. were spelling by phonics and they didn't know any better. Also Court Clerks were notorious for recording data incorrectly. They were as bad as the census takers were from day one. I could be entirely incorrect, and if I am, I apologize. Compiler - Rosie Guthrie]

Stephen PIPKIN married Amelia "THOMSON" on 21 APR 1779 in Duplin County, NC [mentioned in document above]. Amelia was a daughter of David THOMSON, and she was born ca 1755 in Duplin County, NC. She was of Welsh descent. Stephen and William THOMPSON posted for the Marriage Bond, costing 500 pounds. Other postings of their marriage were found in Gates County, NC, and in Lenoir County, NC, list William THOMPSON and William DICKSON as their Bondsman and Witness. [Two of their grandson's were named 'Thompson' which is more proof to me that the name had previously been spelled phonically by those recording the THOMPSON surname in census and Court Records - the 'p' being silent to their ears. Although, I do realize that there are descendants of this day and time that do spell their surname as THOMSON, and as THOMPSON - that is their choice.]

Stephen was appointed to the Office of Constable in Capt. WESTBROOK's District on 10 JUL 1787. He, Richard BASS and William BUCK, posted bond in the sum of 200 pounds. In 1790, he signed a Performance Bond for William BENNETT, who was a Constable in Wayne County, NC, off and on for many years. This would indicate that Stephen was a man of some means at that time.

[I - as the compiler - used the standard form that has been used for a number of years regarding 'age bracket' and it does not agree with the 'age bracket' that Mrs. Lucie "CLIFT" PRICE used when she was reading the census during 1960's on all of the very oldest census available, so I went back and double checked them. I have used the correct format of age brackets on the following. The 'head of house' was the only name recorded.]

There are no notations mentioning that Stephen and Amelia had 'unknown' children that died early in life, so I feel these are visitors in their home. Maybe these 4 children are parentless, for all that I know, and they were living with Stephen and Amelia. If they were their children, they had to have died before adulthood, I would assume, and they were not remembered by any of the immediate descendants. I also find it very interesting to learn that there was a Lewis PEPKIN [misspelled] in the 1790 Duplin Co, NC, census [223-1] & a Lewis PIPKIN in 1790 Dobbs Co, NC, census [123], & several other PIPKINs in Dobbs Co, NC, at that time span. Is one of the males 16 & up, the 'alleged' Stephen THOMPSON who was supposedly the bastard child of Amelia????

Wayne County, NC, Deed Book, Vol. 7, page 152 - Stephen & Amelia sold 784 acres of land for 1200 silver dollars to John REAVES in Wayne Co, NC, on 3 SEP 1800. Witnesses were Britton HOOD & Lewis PIPKIN [his son]. Stephen & Amelia both signed the Deed in 1801 FEB Court. The land was in Wayne County on the south side of Neuse River, both sides of MILLER's branch & adjoining Thomas CRADDOCK's corner to Richard COGDELL's corner, John WESTBROOK's corner & Solomon GRANTHAM's corner - north side of Horse Swamp - trees, etc. This farm was located about 13 miles SW of Goldsboro, Wayne County, NC.

[One descendant of Solomon GRANTHAM married a ROGERS. A descendant of the ROGERS line was Dorothy "ROGERS" KEITH, who was also a PIPKIN descendant.]

Apparently the estimated birth year of the youngest son, Richard PIPKIN, b. ca 1799, is incorrect, unless the census taker made an error & I doubt that he did! So his birth year is going to be changed to 1800, b. after the census & we do not have a census date.

Wayne County, NC, Deed Book, Vol. 7, page 277 - Stephen PIPKIN bought 100 acres of land from Willis PIPKIN in 1801. It is believed he moved to Darlington District, SC, soon thereafter. There is an execution in Wayne County against Stephen PIPKIN as the assignee of John REEVES in 1803. [Another printing says 1804.] It was for court costs in the action of Stephen PIPKIN vs David & Frederick HERRING. He evidently lost as the cost was being taxed against him. There is a note on the paper "Paid by Mr. Sheriff Richard COGDELL". [Stephen probably did not come back from SC for the trial, unless it was held before he left NC.]

5 MAR 1802 - Darlington District, SC, Deed Book A, p. 363 - Stephen PIPKIN to Stephen THOMPSON for the love and good will I have to my stepson 100 acres on the south side of Sparrow Branch at the mouth of Bell Branch.

Wit: Bennett BIZZELL, Barthlomew FIELDS

1810 Darlington District, SC, census:

Darlington District, SC, Deed Book B, page 454 records that Stephen PIPKIN sold 700 acres of land for 400 dollars to Thomas ANDREWS on 3 NOV 1810. The land lay on the run of Sparrow Swamp adjoining Thomas ANDREWS, John HARRELL and Lewis PIPKIN, (oldest son of Stephen). The deed states that Amelia PIPKIN, the wife of Stephen was privately and separately examined and gave her consent and signed her name. It is said that they were about 15 miles from the Pee Dee River. Land being a part of a tract of 1.000 acres granted to Andrew DuBOSE on June 5, 1786.

Witnesses: George HUGGINS, Harriot HUGGINS.

[A son of John HARRELL m. Sophia PIPKIN, the oldest daughter of Stephen and Amelia. My ancestor Micha MIXON lived on Sparrow Swamp, possibly close by this particular land. Andrew DuBOSE, mentioned above, was also my ancestor.]

Stephen and his family left SC and next settled in Pulaski County, GA. In one of the early letters written by one of the descendants it is stated that their route of travel indicated 'overland'. Early Tax Digest for 1818 of Georgia listed the following PIPKIN's - Martin, Barnabas, David, Lewis, Stephen, Abraham, Amos and William. The first 5 are sons of Stephen. The others were without a doubt connecting kin. All of the PIPKINs were living in District 22.

Stephen had Lot 93, 202½ acres; Lewis had Lot 93, 152½ acres; David had Lot 88, 101

acres; Barnabas had Lot 117, 152 acres and Martin had Lot 94, 151 acres. The land owned by David, Lewis, Barnabas and Stephen were adjoining lots and those owned by Martin and William were a short distance away. It appears that the PIPKINs, when they moved to Pulaski County in 1810-1811 bought land from persons in Burke County, GA, the original owners of the land. It is stated that they were about 20 miles from Big Ocmulgee River and about 30 miles from Macon, Bibb Co, GA.

A letter from the Department of State, Atlanta, GA, explains how the PIPKINs got their land, "The original Wilkinson County was divided into 5 districts by survey, and the land granted to persons who were fortunate drawers in the First Land lottery of 1805. After the acquisition of the new territory (to the Ocmulgee River) a survey divided the additional land into districts numbered 6 to 28 and each district was divided into land lots of 202% acres each and numbered. The land was then granted to persons who were fortunate drawers in the 2nd Land Lottery of 1807. The district 22 in which the PIPKINs were, was treated originally as District 22 of Wilkinson County, later, Laurens, Pulaski and Bullock. We have checked the lot numbers indicated and find that they were, with one exception, drawn by persons living in Burks County and were granted between 1807-1810. By checking the map of Bleckley County (cut from Pulaski) we find that the land owned by David, Lewis, Barnabas and Stephen were adjoining lots and those owned by Martin and William [related somehow] were a very short distance away. It appears then that the PIPKINs when they moved into Pulaski County in 1810-1811 bought lands from persons in Burks County."

There are 3 Deeds of sale of this land in Pulaski County; Book G, page 52 - From Stephen PIPKIN to David SMITH on 14 APR 1815; Deed Book G, page 52 - Stephen PIPKIN to William LONG on 14 OCT 1818; and Deed Book G, page 98 - Lewis PIPKIN to K. DAWSON dated 16 OCT 1818. The deed on page 54 is interesting, for while it was listed in the Tax Digest as owned by David PIPKIN, Stephen PIPKIN bought from William LONG for \$400.00. This deed was witnessed by Charles LANG and Martin PIPKIN. This has led to some speculation that Stephen had some interest in the lands of David, Martin, and Barnabas. It is believed that the sons of Stephen, except Lewis, had the land in their names but did not own it outright, since lot 88 was sold by Stephen and it was in David's name. There may be other deeds in Pulaski County. The lands were recorded in 1821. The PIPKIN family was apparently connected to the Regan's Church in Pulaski County, GA. It is now contained in Bleckley County, GA.

Stephen PIPKIN and children, Lewis, Martin, David, and Mary, left Pulaski County, GA, sometime after they sold their land in late 1818 and arrived in Conecuh County, AL, prior to the 1820 census. This census shows that Lewis, David, and Martin had married and had families. Barnabas PIPKIN is not listed for he had joined the Methodist Conference and was stated to have been living in MS.

[It is quite possible that one of these two females could very well have been a daughter of Suzanne, who died prior to 1830. Although, that does not make it true, it is just a thought.]

The town in which they lived for so many years was in, or near, Belleville, Conecuh County, AL. I never considered looking where the County was located, but I can see that it is in the very middle lower part of the State and Evergreen, where some descendants lived, as well as Stephen & Amelia in their latter years, apparently is not too far from the Florida State line. It was stated that Stephen owned about 600 acres of land in Alabama.

Stephen was not listed in the 1840 census for Conecuh County, AL, and said to have died ca 1836-1840. Amelia died 5 MAR 1840, prior to the date of the 1840 census. Her death was recorded in the Diary of Rev. Peter HASKEW of the Belleville Methodist

Alabama Circuit. The exact date of Stephen's death is not known to my knowledge. An obituary of his son Barnabas stated - "My parents were Stephen PIPKIN and Amelia THOMAS...This venerable couple ultimately died in Conecuh County, AL, the father at the age of 83 and the mother at 85." [Thus, if this is correct, although in reality he would have been 'almost 83' unless the census date was in or after August, which we do not know, Stephen's death would also be considered as passing away during the year of 1840, but prior to the census date.]

Other collected data stated that Stephen died in Evergreen, Conecuh County, AL, and was also buried there. Amelia died on 5 MAR 1840 in Evergreen, Conecuh County, AL, in the home of her son Martin, and it is said that she was also buried there. So if someone wants to try to locate their graves, it should be close to the Evergreen area, but the chances of their tombstones still being visible might be out of the question, if they ever had one in the first place. Amelia's funeral service, conducted by Rev. Peter HASKEW was on 17 MAY 1840, although no explanation is given as to why the delay, beings she died 5 MAR 1840. It is not impossible to 'consider' that they were both taken back to the little church in, or near, Belleview where his son, Rev. Lewis PIPKIN was the minister, and it was very near to the Evergreen area. The Alabama Methodist Conference made no notation as to their final resting place, as they did Lewis and Pheraby at a later date in time in Arkansas. That is understandable because Stephen PIPKIN was never stated to have been a pastor in any manner, with exception of one document.

It was said by a descendant of the son, Barnabas, that Stephen was blind in his old age, and he may very well have been. Others stated that his son, Rev Lewis who was blind sometime after the families had moved to Ouachita County, AR, soon after Stephen and Amelia's death. But in later years, Stephen Warner PIPKIN, son of Lewis PIPKIN, was also blind in his old age, so it could be possible that glaucoma was passed down through the genes within some of the descendants, even though that has not been mentioned in any manner.

Mrs. Margaret "McLURE" BAILEY, w/o Russell BAILEY of Coffeeville, MS, wrote the following - "I have been trying to find the graves of Stephen PIPKIN and Amelia "THOMSON" PIPKIN, who I believe are buried at the Old Sardis Church Cemetery near Castleberry, AL, in Conecuh Co, AL. In 1963 my brothers and I were going to Troy, AL, to a McLURE Family Reunion and just happened to see on the roadside a church with the sign, The Belleville Methodist Church. I had my brother stop and we looked at the tombstones in the cemetery adjoining the church and I realized the names were familiar but the dates were too recent. Some people were coming to church so we introduced ourselves and asked them if their church had always been on the spot it is now. They did not know. I suggested that I was almost positive there was an older church somewhere in the area and I asked them to look for it and inquire about it. I really felt that the Old Sardis Church that Rev. Lewis PIPKIN helped to organized was in this vicinity." [Unfortunately, Mrs. BAILEY had been misinformed because the Methodist Conference records are very specific that the Sardis Church that Rev. Lewis PIPKIN helped to organize was near Belleville, but not called the Belleville Methodist Church, although in later years it may very well have been.

Some time between 1846 & 1850, it was stated by various descendants that Lewis, father of John Fletcher PIPKIN, Martin & David, with their families moved to Ouachita County, near Camden, AR, where they lived & died at a good old age. The Methodist Conference records state that it was about 1843.

[NOTE - The Evergreen Public Library indicated to one of the descendants in 1988 that both Stephen and Amelia PIPKIN were buried in a cemetery nearby. It was reported to be in good repair and many PIPKINs were said to be buried there. Although nothing more was learned from the Library, but we do have this 'particular comment' to hopefully be able to rely on as being a true statement.]

the day that she was born when carving the tombstone, which says 19 JUL 1781, or it was a typing error in the first place in the cemetery survey.] Sophia m. in ca 1805 to Spencer HARRELL in Darlington Co, SC, b. 1 DEC 1775 in Wayne Co, NC, s/o John HARRELL & Elizabeth "THOMPSON". [John HARRELL was listed on Micha MIXON's Will' as administrator or signer. Micha MIXON was my ancestor also.] Spencer wrote his 'Will' dated 8 OCT 1845. It is a matter of record at Darlington County, SC, Court House. He d. 24 NOV 1846 in Darlington District, SC, & was buried next to Sophia in the Wesley Chapel Cemetery. [I was unable to locate Sophia in the 1840 & 1850 census.]

Rather than type it over & over again, Lee County, SC, was created in 1902, & the area in which Sophia & Spencer had lived was taken into Lee County, SC, & no longer a part of Darlington. AND this may very well pertain to all of the PIPKIN descendants of Stephen & Amelia for all that I know that lived on the far West side of Darlington County. I may have been misinformed, but the Wesley Chapel Cemetery is said to now be contained in Lee County, SC. It is located on the grounds of the United Methodist Church & I see no need to continually type United Methodist Church, so please keep that in mind.

Probably because he had remarried after her death so the family did not want her to remain buried in the King Cemetery. There is another story about Epsey's remains. Mr. Walter Bell, descendent of Sophia "PIPKIN" HARRELL, removed Epsey's remains from the King Cemetery & placed her in the Wesley Chapel in Lydia, Darlington Co, SC, next to her husband & his 2nd wife, being (2) Mary Ann "VANN", mentioned below. Mario PERRINO was told that Henry & Epsey were both buried in the Mt. Elam Cemetery. [Which of these 3 stories are true, I have no way of knowing for sure.] [NOTE: To confuse the situation, Henry Green KING was a s/o William KING, Jr, called Big Billie, & his $1^{\rm st}$ wife, who passed away & then Big Willie m. (2) Rhoda HARRELL, who was a d/o Sophia PIPKIN, who was the older sister of Suzanne PIPKIN. Suzanne was the mother of Epsie B. BEASLEY, although Epsie was in no way blood kin to her own husband.] Children:

J. [an error in transcribing] P. BEASLEY, 12 MAR 1843, d. 20 NOV 1857, in Chickasaw Co, MS, from pneumonia. She was survived by her husband & six children."

Saphronia Catherine had two sisters, Frances "MIXON" SKINNER and Elizabeth "MIXON" REAVES, and a brother named Jasper C. MIXON, who d. 28 MAR 1888 in Wilcox Co, AL, and had no living children of his own. His heirs were listed as W. J. BEASLEY of Chickasaw Co, MS, R. F. BEASLEY of Jefferson Co, MT, H. S. BEASLEY of Sumter Co, SC, M. A. BEASLEY of Clay Co, MS, F. D. BEASLEY of Clay Co, MS, F. N. BEASLEY of Clay Co, MS, and S. F. REAVES of Washington Co, IL. [The BEASLEY heirs were the children of Saphronia and Ira, even though the initials do not match what was written in combined census. It was indicated by the census that 3 children had died young. But

I realize this was transcribed from the original writings of the Probate records, as well as census is transcribed from the original writings and all are very difficult to comprehend. I cannot identify R. F. & H. S. These initials could have been completely misread by the transcriber of that Probate recording.]

Southern Baptist - 12 JAN 1858 issue - It says that when Simpson MIXON died sometime after 7 SEP 1837, the date of his 'Will', the widow, Mariah, had m. a Mr. JOSEY by the time Simpson MIXON's Will reached the final settlement on 9 JAN 1845. [I find the surname JOSEY interesting because it runs considerably in the PIPKIN ancestry.]

Vol. III, p. 76 - OBITUARY - Southern Baptist of 12 JAN 1858 - Died - Saturday $20^{\rm th}$ NOV 1857, at residence of her husband in Chickasaw Co, MS, of pneumonia, in $33^{\rm rd}$ year, Mrs. Sophronia C. OBITUARY - Ira P. BEASLEY, s/o John & [Suzanne] Anna Pipkin Beasley, (once in Legislature) born 1820 MAR 25, Darlington District, SC, died 1905 JAN 6 near Montpelier, MS, married 1843 MAR 12 to Sophronia C.[atherine] Mixon; married Telitha Mixon, d. JAN 31 1901. Leaves 6 sons and 1 daughter.

[Others say that Ira Pipkin BEASLEY, m. (2) Martha "_____", m. (3) Tabitha "_____".) I do not believe that he ever married a Martha or a Tabitha. Time did not allow, at least by studying the census and mentioned documents. But according to the 1860 census, he m. (2) Telitha F. "

I know that when the initial 'I' is handwritten it does look like a 'J' at times & I feel that is what is showing the confusion in what has been said above. I feel that it is important to locate his 'Last Will & Testament'. For one thing it might list the names of his children.

- 4. Census indicates that there were 4 children, but one was not identified by name & passed away prior to the 1900 census. One of the above mentioned sons was also deceased prior to the 1900 census.

I had a difficult time with this PIPKIN-BEASLEY-HARRELL descendancy also. Many were said to have lived in LA, SC, MS, and other States, but I could not find many of them, so I have done the very best that I can under the circumstances involved. There is now census available on many of the descendants for 1900, 1910, and 1920. But when I finished the HARRELL group, the census was not available. Later I did go back in and finish the search for Ira Pipkin BEASLEY and his siblings. Someone descending from Suzanne can easily finish up this project.
